## 1.0 INTRODUCTION AND SCOPE

TeachScribe Ltd ("TeachScribe", "we", "us" or "our") uses cookies and similar technologies across its public web properties.

This Cookie Policy explains what these technologies are, why we use them, and the choices available to you.

This policy applies to:

- <https://teachscribe.com>; and
- <https://help.teachscribe.com>.

Some functionality on these properties loads third-party services (for example, scheduling through <https://app.cal.com>), which may set their own cookies and browser storage items.

## 2.0 WHAT COOKIES AND SIMILAR TECHNOLOGIES ARE

Cookies are small text files placed on your device when you visit a website. They are widely used to make websites work, improve security, remember preferences, and provide usage information.

We also use similar technologies such as local storage and session storage in your browser. In this policy, we refer to cookies and these similar technologies together as "cookies" unless stated otherwise.

## 3.0 HOW WE USE COOKIES

We use cookies to:

- operate and secure our websites and connected services;
- support requested interactions such as scheduling a demo or using support features;
- remember interface preferences and state where relevant; and
- understand how visitors use our websites so we can improve performance and content.

## 4.0 COOKIE CATEGORIES AND LAWFUL BASIS

We use the following categories:

- **Strictly Necessary:** required to provide a service requested by you, or to maintain core security and integrity of our websites and connected services.
- **Functional:** support helpful features and remembered settings that are not always strictly necessary.
- **Analytics:** help us understand usage, performance, and reliability trends.

Under the Privacy and Electronic Communications Regulations (PECR), strictly necessary cookies can be used without consent where the legal exemption applies.

For non-essential cookies (including analytics and functional cookies that are not strictly necessary), we request consent where required by law.

Where personal data is processed in connection with cookies, the UK GDPR lawful basis is typically:

- **Consent** for non-essential cookies; and

- **Legitimate interests** for strictly necessary security and service operation processing.

## 5.0 DETAILED COOKIE TABLE

The table below reflects a technical scan of TeachScribe public web properties on **15 January 2026**. Cookies may change over time as services are updated.

Some cookies are set on page load, while others are set only after a user action (for example, opening the scheduling widget).

- Use your browser settings to block, delete, or limit cookies and site data.
- Clear local storage and session storage through your browser's site-data controls.

Please note that blocking strictly necessary cookies may cause parts of our websites or connected features (including scheduling and support functions) not to work correctly.

Where consent is required by law (including for non-essential cookies), we will obtain fresh consent before setting cookies on the changed basis. Strictly necessary cookies remain exempt from consent where the legal exemption applies.
